



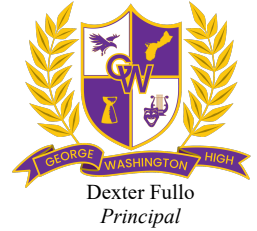

#### CODE OF CONDUCT FOR HALF-DAY STUDENTS

**Part-time enrollment at George Washington High School is permissible for students who are scheduled into all classes necessary for graduation and meet one of the following criteria:**

1. Concurrent enrollment in another educational institute
2. Employment
3. Parental Request

Enrollment in this program is a **privilege, not a right**. It is important that the integrity of the program not be jeopardized. Therefore, in order to participate in this program, both the parent/guardian and student must agree to the terms set forth in this request.

**NOTE: Unscheduled IDs will be assessed a fee of \$10.00 per semester. Replacement IDs will be assessed a fee of \$5.00.**

1. To provide own transportation to/from school		
2. Early arrival and/or late departure to/from the campus will not exceed ten (10) minutes. The waiting area is located near the Main Office. Only seniors with half-day IDs are allowed to wait in this area.		
3. Half-day IDs must be visible at all times when on campus.		
4. Should personal transportation not come on time, student will be scheduled into a class after the second warning. (All warnings will be documented)		
5. Unscheduled students are NOT allowed to be on campus during unscheduled periods unless authorized.
